This Spring, from February 24 to March 8, I have the opportunity to join the McDonald Road Church's youth mission trip to the jungles of Peru. We will be staying at the airbase for Peru Projects near Pucallpa. Peru Projects is a supporting ministry of the Seventh-day Adventist Church that works closely with the local Adventist mission. Some of our goals will be:

1. To draw closer to God through serving others and experiencing life in an economically depressed country.
2. To support our friends, the Doneskys who went there from our church about a year ago.
3. Help build a block wall/fence around the perimeter of the airbase. This is largely to establish the boundaries of their property so that it doesn't get confiscated.
4. To build a chapel for the airbase or a local village. (This project has not yet been finalized).
5. To do a VBS program for one of the local churches there.
6. To support a local church by holding an Evangelistic campaign.

I am excited about what God is going to do in my life and in other's through this ministry. I do, however, need your help. We will be flying to Lima and then taking a local flight to Pucallpa. In order to cover the costs of my trip, I will need to raise around \$1150. I also need to have my ticket price- about \$700 raised by the end of January. Anything you can do to help will be greatly appreciated.
